THINGS TO CONSIDER

In order to determine if you would like to hire an attorney, you should consider how much they will charge for their services, and how much experience they have with immigration matters. It is important that you feel comfortable with the attorney when you speak with him or her.

The rates charged by an attorney may vary depending upon the difficulty of the case, the time involved, as well as the reputation and experience of the attorney. Some may accept monthly payments if you cannot pay the full amount up front. To avoid confusion, ask how much you will be charged for a particular service and whether payment options are available.
